Privacy Policy

How do we receive Personal Information about you?

How do we use Personal Information about you?

BLCH uses this personal information about you:

- To resolve complaints or issues you may have with our Product or service;
- To send you marketing information about our development;

How will we contact you?

You can request erasure of any personal data where the processing isn't necessary for the purposes of the legitimate interests pursued by BLCH or by a third party.
